President Ed Reznicek called the meeting to order at 6:00 PM. Ed Reznicek, Dr. Jeff DeMint, Kathy Lippert, Ann Shaughnessy, Kent Saylor, and Jim Scoby were present. Also present were Superintendent, Todd Evans and Board Clerk, Deb Damman and others who are listed on the attached sheet that becomes a part of these minutes. Board member Leslie Scoby was absent.

Ed Reznicek presented the following changes to the agenda: Agenda Item 1.A.I. will follow Item 3.A.I. Consent Agenda – Item E – Add: Deb Sjulin, WAC Western Center Driver. Consent Agenda – Add Item G - Accept a gift of \$1,500 from Axtell Knights of Columbus for Lunch Account Assistance. Consent Agenda - Add 7.A.I.a. - Resolution (20-3-1-7a) for BOE meeting dates.

Motion by Dr. Jeff DeMint, seconded by Kathy Lippert, to approve the agenda as amended. Motion carried 7-0.

A discussion was held regarding election of school board officers. Motion was made by Kathy Lippert, seconded by Dr. Jeff DeMint, to keep elections at the first meeting of the Board meeting after July 1. Motion carried 6-0.

Motion by Jim Scoby to approve a SES Kindergarten Aide position, seconded by Kent Saylor. Mr. Evans clarified that this position was for this year only. Motion carried 6-0.

Motion was made by Kathy Lippert, seconded by Dr. Jeff DeMint to approve the consent agenda as amended. Motion carried 6-0.

Jim Scoby expressed his thanks to the Axtell Knights of Columbus for the lunch account assistance.

Dr. Jeff DeMint gave an update for the USD 113 Foundation.

Kathy Lippert gave a Legislative update to the Board.

Mrs. Jennifer Gatz presented PreACT information, and updated the Board on Visible Learning.

Mr. Evans shared a concern that there have been no applications for the WAC science position. Board members Kent Saylor and Jim Scoby provided an update regarding the 5<sup>th</sup> grade facilities study. Mr. Saylor provided a document comparing USD 113 expenditures and revenues with area districts. Mr. Evans and Mrs. Gatz provided information about the possibility of adding a kindergarten teacher to SES for next year for a "Transitional Kindergarten" program. Mr. Evans provided the board with the finalized Clean Diesel grant award which provides \$21,136.25 from KDHE. Mr. Evans shared updated information from architect Robert Hansen regarding projected costs for potential improvement items at SES. Mr. Evans reviewed the year-to-date expenditure document as well as KSDE reports for district and building performance and efficiency.

Mr. Evans announced that January is BOE Appreciation Month, presented each Board member with a Certificate of Appreciation and thanked the Board members for their service. Mr. Evans presented positive photos, and showed a USD 113 commercial funded by an Appleseed Grant. He also shared a commercial about the Axtell Community, which was funded by the Axtell Economic Development Council.

Motion by Kathy Lippert, seconded by Dr. Jeff DeMint to extend the Superintendent's contract for 1 year through FY2023. Motion carried 6-0.
